Carroll **MOVED RECOMMENDING COUNCIL APPROVAL OF A UNIVERSAL 15 MPH SPEED LIMIT ON ALL STREETS BOUNDED BY SYCAMORE STREET (BUT NOT INCLUDING SYCAMORE STREET), RANDOLPH AVENUE (BUT NOT INCLUDING RANDOLPH AVENUE), DIAMOND STREET (INCLUDING DIAMOND STREET), AND THE CITY'S EASTERN BOUNDARY, CONSISTING OF CHURCH LANE, PARK STREET, MARRO DRIVE, PROSPECT STREET, BUFFALO STREET, EARLE STREET, GUY STREET, FAYETTE STREET, ELM STREET, GAY STREET BOUNDARY AVENUE, TERRACE AVENUE, SUMMIT STREET, CHERRY STREET, COURT STREET, HIGH STREET, LOCUST STREET, VINE STREET, BOYD STREET, KEY STREET, OAK STREET, VISTA AVENUE, KIRK STREET, DIAMOND STREET, WEESE STREET, HOWE AVENUE, PAULE STREET, BELL STREET, THORNE AVENUE, SLAUGHTERHOUSE HILL ROAD, WOODFORD DRIVE, AND SUGAR HILL LANE.** The motion carried.
